



Except for any express warranty included within the packaging of a specific product, Legrand warrants all professionally installed Nuvo analog products to be free of defect in workmanship or materials for a period of one (1) year from the original date of purchase, and provides a one (1) year warranty for all speakers (henceforth referred to as the “Warranties”). These Warranties apply to the original purchaser only and are not transferable. These Warranties apply and are good only in the United States. For products purchased outside the U.S. or by non-U.S. customers, to the extent any warranty applies, such warranty may be provided by the Authorized Nuvo Dealer from whom the products were originally purchased. Authorized Nuvo Dealers can be found through the Legrand website at: <http://www.legrand.us/where-to-buy.aspx>. (Products purchased from or installed by unauthorized entities are not covered by these Warranties.) These Warranties are subject to the following additional conditions and exclusions:

- Defects caused by wear and tear, misuse, accidents, voltage excess, acts of nature (fire, flood, lightning, natural disasters, etc.) or neglect are not covered by these Warranties.
- Legrand does not warrant that its products will operate error free or without interruption.
- These Warranties do not apply to problems caused by third party accessories or components.
- These Warranties do not apply to products purchased and/or used outside the U.S.
- These Warranties will be void if:
  - a. The unit has been altered or modified.
  - b. The serial number has been removed or defaced.
  - c. The unit is deemed by Nuvo to have lightning damage.
  - d. The unit and/or products were not purchased from an Authorized Nuvo Dealer.

The purchaser must ship the defective product, together with the proof of purchase and purchaser contact information, to either the Authorized Nuvo Dealer from whom the product was purchased, or directly to Legrand at 3015 Kustom Drive Hebron, KY 41048. The purchaser must pay all handling and transportation charges and bear the risk of any loss or damage in transit. Freight collect shipments will be refused. If the Authorized Nuvo Dealer or Nuvo determines that the unit was defective in materials or workmanship, Legrand or the Authorized Nuvo Dealer will, at its sole option, repair or replace this product at no additional charge, except as set for below.

If the model is no longer available or cannot be repaired, Legrand, at its sole option, may replace the product with a current model of equal or greater value. If a new model is substituted, a modification to the mounting surface may be required. Legrand assumes no responsibility or liability for such modification to the mounting surface. Legrand will retain all defective parts and products which have been replaced under these Warranties. Legrand will ship, freight prepaid, the replacement or repaired product under these Warranties, only to the original purchaser.

These Warranties do not extend to products which have been damaged or fail as a result of abuse, neglect, misuse, or as a result of any accident, disaster, overload caused by voltage inputs in excess of the rated maximum for the product, improper packing or shipping procedures, repair, or modification of the product which has not been authorized or approved by Legrand. These Warranties also exclude normal discoloration caused by environmental conditions.

In addition, Legrand may support certain third party technologies, such as specific file formats and content providers. Legrand reserves the right in its sole and absolute discretion, to discontinue access to and/or support for such third party technologies at any time, and for any reason and with no attendant liability. Legrand makes no warranties of any kind regarding the continuing support for any third party content or technologies.

These Warranties are the only warranties provided with respect to the products and are in lieu of any and all other express or implied warranties. If the product is defective in materials or workmanship only as warranted above, the purchaser’s sole and exclusive remedy shall be repair or replacement as provided above. In no event will Legrand be liable for an incidental, indirect, direct, or consequential damages arising out of use or the inability to



use the product, even if any other party has advised Legrand or an Authorized Nuvo Dealer of the possibility of such damages. Some states do not allow the exclusion of limitation of consequential damages, so the above limitation and exclusion may not apply.

If Legrand or its Authorized Nuvo Dealer determines that the problem is not due to a covered defect in materials and workmanship, Legrand will contact the purchaser for instructions as to disposition or repair of the product, with any repair performed subject to charge. Legrand's determination as to the cause of the problem shall be final and binding.

This warranty goes into effect on September 1, 2015. All items purchased before September 1, 2015 from Nuvo Analog and Speaker categories have the three (3) year warranty.
